

**Town of Mackford**  
**Regular Town Board Meeting Minutes**

**Call to Order**

**Road Report**

- Snow Plowing

  - It was asked if any nearby municipalities own their own equipment that we could hire.
- Brush Clean Up
  - Tichora Road, Sunny Road, and Prairie Road have overhanging tree limbs and brush that needs to be cut back. Possibly hire Koplan-Kinas to do the work.

**Tender 309 Tank Damage**

- The tank has a split in it from a collision. The tank is under warranty but the cost to remove and reinstall it is not covered. The cost will be approximately \$9000. The board agreed to approve the cost if there are no other affordable options.

**EMT Station**

- The fire dept is looking to add a station in Kingston or Manchester. After some discussion, the board felt that Manchester would be a better location but is contingent on the new highway dept building completion. More discussion will happen at the next fire meeting.
